The bids will be opened in the presence of Bidders' representatives who choose to attend at 2082/10/23 1:00 pm at the office of National Animal Feed and Livestock Quality Management Laboratory, Hariharbhawan, Lalitpur. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NPR 45,000, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2083/01/09).
